**Sub:- Admissions for the academic year 2018-19 in 1<sup>st</sup> BHMS course and continuation of 2<sup>nd</sup> BHMS Course with intake capacity of 100 seats at Jay Jalaram Homoeopathic Medical College, Pachmahal Gujarat- Reg.**

Sir,

In continuation to this Ministry's letter of even No. dated 01.11.2017 wherein a Letter of Permission was issued to the college to start a new Homoeopathic College in the name of **Jay Jalaram Homoeopathic Medical College, Pachmahal, Gujarat** with 100 seats in BHMS course under section 12 A of HCC Act, 1973 for academic year 2017-18, I am directed to say that in order to verify the compliance of the College, the Board of Governors to Central Council of Homoeopathy has conducted inspection of Jay Jalaram Homoeopathic Medical College, Pachmahal Gujarat, on 18.06.2018 and furnished its recommendation as under:

*“Recommended for allowing admission in the 1- BHMS and continuation of 2<sup>nd</sup> BHMS Course for the session 2018-19 with the intake capacity allowed earlier subject to the removal of deficiencies reflected in the report of inspection before 31.12.2018. “*

2. After considering the provisions of section 12C (1) of Homoeopathy Central Council (Amendment) Ordinance, 2018, HCC(MSR) Regulations, 2013, recommendations of the Board of Governors to CCH, observation of the Hearing Committee and Policy of the Central Government for granting conditional permission during the session 2018-19, **conditional permission of the Central Government is hereby granted to Jay Jalaram Homoeopathic Medical College, Pachmahal, Gujarat , for taking admissions in 1<sup>st</sup> BHMS course and continuation of 2<sup>nd</sup> BHMS Course with intake capacity of 100 seats for the academic year 2018-19 subject to condition that the college shall fulfill the following requirements by 31<sup>st</sup> December, 2018:**

- i. All the Minimum Standard Requirements of infrastructure and teaching & training facilities as specified in Regulation 3 of the “Homoeopathy Central Council (Minimum Standards Requirement of Homoeopathic Colleges and attached Hospitals) Regulations 2013” by 31<sup>st</sup> December 2018 to get permission for a period not exceeding five years. Failing which, all the existing colleges, which are not able to achieve full compliance of the requirement as specified in these regulations by the 31<sup>st</sup> December, 2018, shall be denied permission from academic year 2019-20 onwards and action as envisaged under section 19 of the Act shall be initiated against all such colleges apart from rejection of their applications under sections 12A, which have been under consideration by way of conditional permissions or denials”; and

- ii. All the requirements under the provisions of the HCC Act, 1973 and relevant Regulations made thereunder should be fulfilled *in toto*.
3. The college has to develop the requisite infrastructure for above said BHMS courses well in time as per the CCH norms which will be verified and reported by the CCH at least three months before the start of next professional and accordingly, the permission for taking admissions in subsequent academic session will be issued.
4. The college administration may take up the matter for recognition of the qualification under section 13(1) of the HCC Act, 1973 at that time when the first batch of students admitted against this course appears for the first final professional examination of the said course.
5. Please acknowledge the receipt of this letter.
