Application for letter of permission for functioning of Jay Jalaram Homoeopathic Medical College, At & Post Morva (Rena), Takula Shahera, Distt. Panchmahal – 389001, Distt. Panchmahal – 389001, for Admission in BHMS Undergraduate Course with Intake Capacity of 100 seats for academic year 2025-26 – reg.

Sir/Madam,

Jay Jalaram Homoeopathic Medical College, At & Post Morva (Rena), Takula Shahera, Distt. Panchmahal – 389001, Gujarat has submitted an application for permission for sanction of 100 seats in BHMS course for academic year 2025-26. The College has submitted the Part 1 information in which the entire functional profile has been narrated. The Medical Assessment and Rating Board (MARBH) has conducted Inspection on 10.06.2025 and 11.06.2025, followed by Virtual hearing on 25.06.2025. MARBH has examined the profile of the College as to whether the college fulfils the Minimum Essential Standards 2024 as per the prevailing regulations under clauses 26 and 28 of the NCH Act 2020. On careful examination of the report, the Medical Assessment and Rating Board observed the following shortfalls: -

## 1. Deficiency of Teaching Faculty (07 deficiency)

- a) Department of Anatomy: One Assistant Professor is not available.
- b) Department of Pathology and Microbiology: One Professor is not available.
- c) Department of Gynecology & obstetrics: One Professor is not available.
- d) Department of Surgery: One Professor is not available.
- e) Department of Community Medicine, Research Methodology and Biostatics: One Professor, One Assistant Professor are not available.
- f) Department of Organon: One Professor is not available.

As evident from the above statement, a total number of 07 UG teacher deficient against the requirement of 40 + 1 for 100 seats UG college established in 2023 (As specified in MES, 2024). Pursuant to F.No.:3-2/MARBH/NCH/2025-26/162-169 dated 16/04/2025 issued by MARBH, a college can avail 10% relaxation against the required number of teachers for Academic Year 2025-26 only. After allowing relaxation of 10%, college has 03 deficiency of teachers. However, such relaxed number of teachers may be appointed at the earliest for smooth conduct of course.

## 2. Miscellaneous:

- i. College has not applied for NABL accreditation for clinical laboratory.
- ii. Salary is not according to MES -2024.

Considering the above observations during inspection and hearing, MARBH has decided to issue Conditional permission to Jay Jalaram Homoeopathic Medical College, At & Post Morva (Rena), Takula Shahera, Distt. Panchmahal – 389001, Gujarat for continuing UG (BHMS) course with intake capacity of 100 seats for academic year 2025-26, on the basis of following conditions: -

- a) College has to apply for NABL accreditation for clinical laboratory.
- b) College should appoint:
  - One Professor in the Department of Physiology and Microbiology.
  - One Professor in the Department of Gynecology & obstetrics
  - One Professor in the Department of Organon.
- c) Pay scale of all the teaching staff should be according to MES -2024.

The institute will rectify all the above deficiencies within a month and compliance shall be submitted to MARBH, failing which permission may be withdrawn.

- 3. All admissions shall be made from NEET qualified candidates only. It is further informed that minimum 15% of seats of the permitted intake capacity of 100 seats for BHMS course shall be treated as All India Quota. Counseling for seats under All India Quota shall be conducted by Central Government and counseling for the remaining 85% seats or as the case may be, shall be conducted by the concerned counseling authority of the state/UT designated by Central Government. The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the Central Government for All India Quota or the student admitted thereunder.
- 4. The Category wise list of the selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET qualified students will not be approved by the Medical Assessment and Rating Board.
